Please report on the measures taken to implement the recommendations contained in the Committee's previous concluding observations,¹ including regarding the role played by civil society organisations, relevant statistical data and information on the mechanisms in place to review the process of implementation of previous recommendations. Please provide information on any other significant developments in the legal and institutional framework within which the human rights enshrined in the Covenant are promoted and protected that have taken place since the adoption of the previous concluding observations.

Anti-corruption measures (arts. 2 and 25)

4. Please report on the legal, policy and institutional frameworks in place to prevent and combat corruption effectively, including on measures taken to strengthen the accountability and transparency of the Government. Please describe the measures taken to promote good governance, transparency and accountability, including with regard to public procurement and to the declaration of assets and conflicts of interest. Please indicate any plans to rescind the Head of State's powers to block or discontinue criminal proceedings against individuals with top executive functions who are suspected of having committed corruption related offences and provide information on any instances where this power has been applied during the period under review, including the process and criteria to apply it.

Non-discrimination (arts. 2, 19, 20 and 26)

In particular describe any measures planned to provide persons with disabilities in practice, unhindered access to justice, education, employment, and political participation.

Discrimination based on sexual orientation or gender identity (arts. 2, 7 and 266)

8. Please provide information on the measures taken to prohibit all forms of discrimination, including the practice of so-called conversion therapy against lesbian, gay, bisexual and transgender (LGBT) persons. Please also describe the requirements in place for the legal recognition of gender reassignment. Bearing in mind the legal recognition of same-sex marriages in the State Party since 1 January 2025, please provide information on measures taken to ensure access to the rights and benefits associated with marriage and family life without discrimination based on sexual orientation or gender identity.

Gender equality (arts. 3 and 26)

9. In reference to the Committee's previous concluding observations (para. 16), please provide information on measures taken to strengthen the participation of women in the public and private sectors, particularly in decision-making positions. Please describe the measures taken to ensure full and equal participation of women with disabilities, migrant women, and Muslim women in all spheres of life. Please also describe the measures taken to promote gender equality between men and women and combat gender stereotypes on the roles of women in the family and society.

Violence against women and domestic violence (arts. 2, 3, 6, 7 and 26)

10. Please provide information on measures taken by the State party to address all types of gender-based violence, including sexual violence, stalking and sexual harassment. In particular, please describe measures taken to: (a) ensure effective preventive measures and early identification of such violence; and (b) ensure that all acts of violence are effectively reported, prosecuted and sanctioned, including on measures taken to guarantee prompt and effective investigations. Please provide information disaggregated by gender, age, relationship between the victim and the perpetrator, and type of offence, on the number of complaints, investigations, prosecutions, sentences and protection orders concerning cases of gender-based violence during the reporting period and on the availability of shelters and other services for victims of such violence.

Voluntary termination of pregnancy and sexual and reproductive rights (arts. 2, 3 and 6)

In the light of the Committee's previous concluding observations (para. 22), and bearing in mind the Committee's general comment No. 36 (2018) on the right to life, please provide information on: (a) efforts to revise the regulations governing the voluntary interruption of pregnancy to bring them in line with the Covenant, in particular regarding the steps undertaken to ensure effective access to safe and legal abortions; (b) steps taken to ensure the availability and accessibility of sexual and reproductive health services and education programmes for women, men and adolescents.

Prohibition of torture and other cruel, inhuman or degrading treatment or punishment (art. 7)

12. In the light of the Committee's previous concluding observations (paras. 29-30), please provide information on measures taken to enact a prohibition on torture that is compliant with article 7 of the Covenant and with internationally recognised standards, to ensure that it is punishable by penalties commensurate with the gravity of the crime and that it is not subject to any statute of limitations. Please describe the legal safeguards in place to prevent torture and other forms of ill-treatment, in particular, clarify whether interrogations are routinely audio- and video-recorded, whether such recordings are accessible to investigators, detainees, and legal counsel and about the measures taken to implement the Principles on Effective Interviewing for Investigations and Information-Gathering (the Méndez Principles). Furthermore, please explain whether juveniles are guaranteed access to a trusted person and legal aid during questioning as a standard procedural safeguard.

Treatment of persons deprived of their liberty (art. 10)

In the light of the Committee's previous concluding observations (paras. 23-26), please provide information in relation to conditions of detention, including availability of adequate health care and access to employment integration services. Please indicate the steps taken to monitor and safeguard the rights of persons deprived of their liberty who are transferred abroad to serve their sentences. Please describe the legal framework regarding the confinement of patients in psychiatric or social welfare institutions, particularly regarding the procedures for challenging any involuntary confinement, the measures to ensure that the lawfulness of such deprivation of liberty is subject to regular judicial review and the measures in place to monitor such confinement when it takes place abroad.

Elimination of slavery, servitude and trafficking in persons (arts. 7, 8 and 24)

14. Please provide information on the measures taken to prevent and combat trafficking in persons, forced labour and domestic servitude. Please include disaggregated data on the number and types of complaints lodged, investigations opened, prosecutions initiated and conviction handed down, the nature of the sentences pronounced and any reparation granted to victims. Please provide information on specialized training provided to judges, prosecutors, police officers and other relevant State officials to enable them to identify victims of trafficking, forced labour and servitude, carry out investigations, and initiate legal proceedings, as well as about the awareness and prevention campaigns launched.

Migrants, refugees, asylum-seekers and stateless persons (arts. 7, 9, 12, 13 and 24)

15. Please provide information on measures taken to strengthen the protection of non-citizens in the State party, including migrants, refugees and asylum-seekers, in particular to ensure the equal protection by the law and equality before the law. In the light of the Committee's previous concluding observations (para. 32), please provide information on measures implemented to ensure that provisions on the withdrawal of residence permits of those reliant on social benefits who have been living in the State party for less than 15 years does not have an unfair impact on those in genuine need or put vulnerable persons at even greater risk. Please provide data on the number of residence permits that were withdrawn and the reasons for such decision, during the reporting period.

16. Please indicate what measures, if any, have been taken to establish a statelessness determination procedure. Please report on measures taken to facilitate the right of every child to acquire a nationality, including children born to parents who are beneficiaries of international protection, asylum-seekers or stateless.

Access to justice (arts. 2 and 14)
